Re: Year 6 Christmas Market

Dear Parents/Carers of Year 6,

Every year, Year 6's are always extremely excited to run their own Christmas Market. We are delighted to announce that the Year 6 Christmas Market has been approved to go ahead with clear Covid 19 safety measures in place.

All the money that is raised from the Year 6 Christmas Market will go towards their end of year leaving party and yearbooks. It is, most certainly, a firm favourite at Hampton Junior School. This year, it will look different with **only Year 6 pupils** being able to participate. Nevertheless we are very excited that it is still going ahead albeit on a smaller scale; we are happy to see these traditional events still being able to occur.

Covid-19 Safety Measures:

We are, as always, keeping the safety of the students and staff, of the planning, at the forefront. In order to operate, **all** the Christmas market stalls will all be held outside in the back playground and all resources for the stalls will need to be in school by **Friday 11th December** in a clearly labelled bag.

This year, so that our stalls can run successfully and with safety precautions in place, we do ask that the Year 6 stalls do **not** use: *water, cream, sell home-made cakes/cupcakes and create messy stalls with food products within a bowl e.g. baked beans/spaghetti hoops/porridge.*

If pupils wish to sell sweets/chocolates as part of their stall, we do ask that all food **must be** store-bought and individually packaged.

How will the money be collected for the stalls?

This year, we are adopting a no-cash policy and all payments towards the Christmas Market will be made via **Parent Pay**. In order for a child to have a go on a stall, they will need to hand in a token; we have decided on the following prices:

25p = 1 token

£1 = 4 tokens

In order for your child to receive their pre-paid token, please could you log onto Parent Pay and select how much you would like to donate to the market. Your child's class teacher, will then receive a print out from Parent Pay and hand out the tokens for the pupils to spend. Please note that the minimum spend (per day) is £2 = 8 tokens and the maximum amount (per day) will be £10 = 40 tokens.





When you log onto Parent Pay, you will see the following:

Please note that the deadline to pay via Parent Pay will be **Thursday 10th December.**

Please see below the summary of the key dates for the Year 6 Christmas Market.
Thursday 10th December – Deadline for the tokens to be paid for via Parent Pay
Friday 11th December – All resources for the stalls will need to be in school ready for the stalls to be set up for the following week.

(The market will run for three days, with each class having an opportunity to run stalls. This means that the children will be able to spend their tokens across the two days and will have a chance to visit each other’s stalls - as shown in the table below.)
